I, Simon Paris, declare as follows:

I am a Partner of the law firm of Saltz, Mongeluzzi, Barrett & Bendesky, P.C..
 My firm is counsel to Sicilian Chefs, Inc. d/b/a Caesar's Pasta Products, a plaintiff in this action.
 I make this Declaration based on my personal knowledge. If called as a witness, I could and would competently testify to the matters stated herein.

2. This Declaration pertains to the hours worked by professionals in my firm, and the expenses incurred by this firm, during the period from January 2009 through February 2011. My firm has submitted to Interim Co-Lead Counsel in this case (i) monthly reports setting forth the hours which this firm (by individual) has devoted to work on this case for the foregoing period of time, and (ii) monthly reports setting forth the expenses incurred in connection with this firm's work on the case during that same period.
