DECLARATION OF ALLAN STEYER, ESQUIRE

I, Allan Steyer, declare as follows:

- 1. I am a member of the law firm of Steyer Lowenthal Boodrookas Alvarez & Smith LLP. My firm is counsel to T.K. Ribbing's Family Restaurant, LLC, a plaintiff in this action. I make this Declaration based on my personal knowledge. If called as a witness, I could and would competently testify to the matters stated herein.
- 2. This Declaration pertains to the hours worked by professionals in my firm, and the expenses incurred by this firm, during the period from January 2009 through February 2011. My firm has submitted to Interim Co-Lead Counsel in this case (i) monthly reports setting forth the hours which this firm (by individual) has devoted to work on this case for the foregoing period of time, and (ii) monthly reports setting forth the expenses incurred in connection with this firm's work on the case during that same period. The lodestar amount reflected in the reports attached hereto is for work assigned by Interim Co-Lead Class Counsel and was performed by professional staff at my law firm for the benefit of the Direct Purchaser Plaintiff Class. I have reviewed the lodestar reports attached hereto and can confirm that they are true and correct. All work reported by individuals (attorneys and non-attorneys) on behalf of the Direct Purchaser Plaintiff Class in this matter was performed on a wholly contingent basis. The rates set forth in the monthly reports attached as Exhibit 2 are the usual


and customary, historical hourly rates in effect at the time work was performed. These rates are the same as, or substantially similar to, rates used by my firm in similar types of actions. 


